

# The Forestry Association's Distinguished Service Award



Join the Forestry Association of South Carolina in giving credit where it's due -- to those who have made outstanding contributions to forestry in the state. Nominations are accepted each year for the Association's "Best In The Business" awards to recognize deserving individuals or organizations.

A plaque is presented by the Association to the winner of the Charles H. Flory Distinguished Service Award during the Annual Meeting.

The recipient must be a resident of South Carolina but not necessarily a member of the Association. An individual, organization, professional or non-professional can be nominated. Nominees may be: journalists, legislators, foresters, research scientists, educators, industry, public agencies, and private organizations.

**CANDIDATES:** Once nominated, the candidate is given immediate consideration, and remains eligible for the next two years.

**SELECTION:** The President will appoint a Chairman each year to direct the activities of the awards program. The Committee will be authorized to seek out any information regarding the authenticity of any candidate nominated. After the nomination deadline, the President will appoint a judging committee to screen nominees and make their recommendation to the Board of Directors for approval.

The award will not be a compulsory annual award. Selection will be based on the nominee's record of accomplishment which indicates a willingness to go "beyond the call of duty."
